TREASURER'S REPORT TO THE GNC for April 2021 (revised 7/11/21)

The monthly Treasurer's Report to the GNC is a record of financial activity that uses cash-basis accounting in which revenue is recognized when the money is received and expenses are recognized when money is spent. In addition, the Treasurer's Report to the GNC lists any Accounts Payable that were due during the month but not paid.

SUMMARY

Total income is up 13% from the prior month. This is due to revenue from a recent direct mail, three large donations (totaling \$3000) and ANM revenue continuing to come in. That said, all fundraising categories continue to trail monthly targets but total fundraising revenue continues to increase in absolute numbers as well as as a percentage of our intended income. This month, we brought in 88% of our target, compared with an average of 65% of targeted revenue in the prior three months of the year.

Expenses decreased significantly this month. The only major expense this month was a Ballot Access grant to Arkansas.

RESERVE FUNDS

Fiscal policy requires that we keep three months' worth of core operating expenses on hand in "reserves." Currently, this is roughly equivalent to \$60,000. In 2017, the Steering Committee also voted to put a one-time payment from the Jill Stein campaign, to pay for meeting space at the 2016 Presidential Nominating Convention, in reserve (\$18K). In November 2020, the SC voted to create a legal reserve fund with \$12,000 of the \$18K from the Stein campaign.

Funds donated directly to caucuses and committees are also held in reserves, minus a 10% overhead fee.

Annual National Meeting registrations are also held in reserves during the registration period, to ensure that funds are available by the time bills come due for the actual meeting. As of this report, there is \$2260 in ANM revenue.
